**REVIEW OF NAVAL RECORD**

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that he was authorized an extension of the 180 day period in which to ship his household goods (HHGs) at government expense incident to his separation from active duty of 31 March 1998. Other travel entitlements were not addressed; however, settlement for storage charges, when applicable, is in accordance with the provision of JFTR, Vol 1, paragraph U5375.

2. The Board, consisting of Mses. Newman, Taylor, and Mr. Flood, reviewed Petitioner's allegations of error and injustice on 21 September 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

**CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. By letter dated 10 September 1998, vice any other date, directed to the appropriate naval authorities, Petitioner requested an extension in accordance with the JFTR, Volume 1, paragraph U5360.G of the 180 days in which to ship his HHGs, and that by letter dated 11 September 1998, addressed to Petitioner, the appropriate naval authorities approved Petitioner's request for an additional period not to exceed 24 months from 27 September 1998. Petitioner's entitlement to ship HHGs at government expense incident to his separation from active duty of 31 March 1998 will expire on 27 September 2000 and no additional extensions for entitlement to ship HHGs incident to his separation of 31 March 1998 will be authorized.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
